E.0 Counterfeit Prevention

Procure only from Original Equipment Manufacturer (OEM) or OEM franchised distributors. If unable to procure from OEM or OEM franchised distributors, Borsight must be informed and the supplier providing the non-OEM parts and materials must be identified.

Monitor supply to identify possible penetration of OEM supply chain.

Must have a process to verify counterfeit and report counterfeit parts and materials to Borsight immediately.
