Contract: FA8730-21-F-0061 Mobility Air Force (MAF) Tactical Data Link (TDL) Situational Awareness (SA) Operational Support (OS)

When applicable, Borsight requires our suppliers to:

- Implement a quality management system.
- Notify Borsight of nonconforming processes, products, or services pertaining to our purchase order and obtain our approval before dispositioning.
- Prevent the use of counterfeit parts and materials per the AS9100 standard.
- Notify Borsight of changes to the product form, fit, or function.
- Provide Certificate of Conformance.
- Follow appropriate Electrostatic Discharge (ESD) industry standards.
- Take appropriate Foreign Object Debris (FOD) control measures.
- Maintain proper design and development controls by using appropriate drawings, following key characteristics, and tie back to the original requirements.
- Retain documented information, including retention periods and disposition requirements.
- Ensure that items with a date of expiration have a shelf life of 80% or greater remaining.
- Allow the right of access by Borsight, our customers, and regulatory authorities to the applicable areas of facilities and to applicable documented information at any level of the supply chain.
- Ensure that personnel are aware of:
 - their contribution to product or service conformity;
 - their contribution to product safety; and
 - the importance of ethical behavior.

All supplier's quality control, on time delivery, and other pertinent performance metrics are monitored and evaluated by our Supplier Management Representative, Quality Management System Representative (QMSR), and Management Review team. Suppliers are expected to have effective communication with Borsight and its personnel.
